PLAN C CHECKLIST (to be completed before August 1, 2011)

- Pay your tuition deposit, which is due within 10 days of registering for your first course.
- Create your invoice at www.kucapplications.ca and submit a signed copy to Student Financial Services at King's.
- Pay your deposit and first installment by cash, cheque, debit, online/telephone banking, bank draft or money order.
- Complete and submit a Pre-Authorization Banking form with a void cheque attached.

* **Full-time Students** are defined as students enrolled in 3.5 full-course equivalents (credits) or more for invoicing purposes.

* **Residence Fees:** additional fees are charged for single rooms and upgraded meal plans.

PENALTIES FOR RETURNED PAYMENTS

* **First returned payment:** a \$50 administrative fee plus a \$40 NSF returned cheque charge

* **Second returned payment:** considered to be in default of the agreement and removed from Plan C.

A \$65 administrative fee plus a \$40 returned cheque charge assessed AND required to pay the remaining account balance in full.
