- 1) Starting in mid-July, students can access personalized invoices/statements online at <https://www.kingscollege.net/sfsPortal>. Invoices are available in an electronic format and are NOT mailed out.
- 2) Statements contain all charges and payments; however do not include due dates. Please refer to fee schedules for due dates.
- 3) If you start your program in January, your fees are due no later than December 15th, 2022.
- 4) Payments can be made by cheque, bank draft, money order, online/telephone banking, debit card, credit card or electronic wire transfer. Please see the Payment Methods section of our website for more info.
- 5) Please make all fees payable to "King's University College".
- 6) A breakdown of all Student Compulsory Fees can be found in the Fees Schedules section on our Money Matters page. Information on available opt-outs can be found on this breakdown.
- 7) All students attending King's/Western for the first time are assessed a \$32.00 fee for a student card.
- 8) Withdrawal, Cancellation and Refund information can be found in the Refund/Withdrawal Section of the Money Matters Page on our website.
- 9) Students offered late admission to King's are given 10 business days to make the 1st payment before late charges apply.
- 10) Late payment fees will be applied to all payments received after the due dates specified above: Full Time students \$401.00 Part Time Students \$200.50.
- 11) King's University College reserves the right to withdraw students from their registered courses and/or residence for non-payment of fees and request pre-payment prior to enrolment.
