Course Description

This course will explore the adjustment to change, transition, and loss from the perspective of bereavement theory and research. Students will examine concepts relevant to a variety of losses which are not necessarily associated with a death event, but which are associated with grief and adjustment issues. Topics such as non-finite loss, chronic sorrow, ambiguous loss, and non-death loss will be explored for their unique aspects. Relevant issues such as infertility, aging, loss of functionality, chronic illness and degenerative conditions, divorce and separation, immigration, adoption, and loss of employment will be included in course discussions and materials.

Course Objectives

- 1. Identify and describe death and non-death losses across the lifespan.
- 2. Discuss traditional and contemporary theories related to grief and bereavement.
- 3. Define concepts such as chronic sorrow, complicated grief, non-finite loss, ambiguous loss, tangible and intangible losses, and non-death loss.
- 4. Situate everyday loss experiences and grief responses to loss within broader societal and political contexts.
- 5. Reflect upon and analyze their own losses using scholarly works.
- 6. Discuss common interventions in supporting the bereaved.

Structure of the Course

This course begins on Wednesday, September 11, 2024, and continues until Wednesday, December 4, 2024, honouring all important dates derived from University approved guidelines and academic policies (https://www.kings.uwo.ca/current-students/academic-resources/academic-dates-and-events/).

This course incorporates both lectures and dialogic discourse and is designed to promote engaged critical thinking. It is important to **complete all required readings**, **videos**, **and any other materials BEFORE CLASS** in order to best engage your colleagues in a discussion of various topics relating to the field of Thanatology. Students are expected to participate by asking relevant questions and/or by providing appropriate critiques and examples. The responsibility for a successful learning experience is shared by all the participants – students and professor alike. I am trusting that you will share in the responsibility in making this a successful learning experience.

Participation and Attendance

Students are expected to attend class having read assigned readings and prepared to engage in discussion. Attendance will be monitored via sign-in sheet at the end of every class. If you need to leave class early, please speak with the instructor before class or during the break. Students that miss three (3) or more classes are at risk for debarment from the final exam (see below).

There will be opportunities to present personal experiences and feelings to the class. We must respect each person's contribution of what may often be painful experiences (at the same time appropriate limits to self-disclosure or to the time allotted to individuals will be upheld when personal narratives are shared) and agree to hold each other's contributions **strictly confidential**. This is an academic course, and all participants are required to complete the course requirements to a high standard to receive credit. One's strong feelings or experiences will not substitute for effort, scholarly engagement, and academic achievement.

Personal Loss Assignment (due October 30, 2024 by 11:30am)

This assignment will be 8-10 written pages PLUS a title page and reference page. As a means to encourage creativity, students will also include a PowerPoint, video, or other visual format (photo, drawing, painting, collage, concept map, etc.) to represent their own loss timeline. Book Review/Theory Integration Assignment (due December 4, 2024 by 11:30am)

The book review will be 8-10 written pages PLUS a title page and reference page. Students will select one book to review from a predetermined list (see Texts and Readings above). Further guidelines are available on OWL under Assignments.

Final Exam

This exam will be scheduled during the December exam period. This exam will consist of multiple choice, short answer, and essay questions and will cover material from the entire term. Students are responsible for material covered in the lectures, all supplementary readings on OWL, the assigned chapters in our textbook, as well as in-class discussions.

Tokens

All students have one (1) "token" which can be used to have a 2-day extension on any regular assignment (not including final exams) as long as Dr. Sauder is notified by email no later than the day the assignment is due (no explanation or documentation required).

Bonus Assignment - Optional (10%; due October 4, 2024 by 5:00pm)

On Thursday September 19, 2024, a Grief Literacy Symposium and Photovoice Exhibit is being held at King's University College. Attend any event that day (there are several panels and exhibits) and complete the assignment (details available on OWL).

*Instructions regarding assignments - Evaluation for all assignments will include professionalism, academic integrity, and adherence to APA formatting (7th ed.). Regular assignments are due by 11:30am on the date indicated unless an extension is granted prior to the deadline. All written assignments turned into OWL via the assignment tab must be in Word format (not pdf or any other format). If submitted in any other format, it will be marked as late and the student will be asked to resubmit.

Late Penalties

Normally, the only acceptable reasons for late or missed assignments are illness (for which a doctor's note may be required) or extreme compassionate circumstances. Unexcused late assignments will be penalized as follows: Assignments handed in after 11:30am but no later than 11:55pm on the due date will lose 2%. Assignments handed in a day late will lose an additional 3%. After that, an additional 5% per day penalty will apply and assignments will not be accepted more than 7 days after the due date unless prior arrangements have been made with the instructor.

Policy Re: Make-Up Exams and Extensions of Deadlines

If, on medical or compassionate grounds, you are unable to write a midterm test or final examination or complete course work by the due date, you should follow the instructions below. In addition, you must demonstrate that there are compelling medical or compassionate grounds that can be documented **before** academic accommodation will be considered.

You should understand that academic accommodation will not be granted automatically on request. Instructors are under no obligation to offer more than one opportunity to write a make-up exam. Please note that any requests for discretion by the instructor will be decided on the basis of the issue that is brought to the instructor's attention and the instructor's obligation to ensure fairness to all students in the classroom. The instructor will not agree to any concessions or accommodations that would be unfair to the other students in the class.

Debarment of Students from Writing the Final Examination

1. A student may be debarred from writing the final examination for failure to maintain satisfactory academic standing throughout the academic year.

2. Any student who, in the opinion of the instructor, is absent too frequently from class in any course will be reported to the Chair of the Department of Thanatology (after due warning has been given). On the recommendation of the department chair, and with the permission of the Academic Dean, the student will be debarred from taking the regular examination in the course.

AI and Chat GPT. Please consider how you address me in your salutation. This is an academic class and I am your professor. Also, consider the tone of your email. I will respond to your email within 2 business days. If you have not heard from me after 2 business days, then please feel free to contact me again. I will not respond to emails over the weekend.

Note on Changing Marks. Marks will not be changed.

If a student seeks to change their grade without legitimate ground for such changes they will be directed to the Academic Dean's Office.

I know students are in the habit of sharing and comparing marks. I don't encourage this because it just causes problems and competition between one another. Do not worry about what grades other students receive. Your work is not being graded against the quality of work that is presented by other students. Please

do not tell the instructor how to grade other students. I will only discuss your marks with you, not another student's marks.

General Course Policies

1. Academic Accommodations, Consideration for Absences

Academic Accommodation (Accessibility)
